

# Pathway Home Operation Brings 30 People Inside in Santa Fe Springs

On December 19, 2024, 30 people living along the San Gabriel River and the 605 Freeway in Santa Fe Springs were moved out of encampments and into interim housing. This is the latest LA County "Pathway Home" operation in Supervisor Hahn's district which uses local motels to bring entire encampments inside

at once.

"Encampments are communities and we have seen that people are more likely to accept help and housing if they know their entire encampment is accepting help together," said Supervisor Janice Hahn. "I am grateful that thanks to the hard work of our outreach workers, first responders, and public works employees, these 30 individuals are inside safe for the holidays and on a pathway to long-

term housing."

The operation was organized by the LA County Homeless Initiative in collaboration with LAHSA, the LA County Sheriff's Department, the City of Santa Fe Springs, and the LA County Department of Public Works. All 30 unhoused individuals were moved into 25 rooms in a local motel master-leased by the County.

# Montebello Rescinds \$1.5M Contract After Report That City Violated Pubic Contract Code

The City Manager had recommended a company with a bid \$536,000 more than the lowest responsible bidder.

Last week, Los Cerritos Community News obtained a letter from the Sacramento-based law firm of Weinberg, Roger, and Rosenfield [WRR] alleging that the city of Montebello violated the Public Contract Code and Montebello Municipal Code in awarding a Transportation Facility, Restroom Renovation Project [Project] contract to KYA Services, LLC.

The letter threatened litigation if Montebello did not cancel the bid award. "WRR would prefer to avoid legal action. However, if the City insists on procuring the Project, WRR will

consider legal action, up to and including litigation remedies. We will also seek to recover all attorney fees and expenses incurred, as permitted by law."

The possible litigation involved a Request for Proposals for the Project sent out in July that indicated that the scope of work is to "renovate the restrooms in the Transportation Administration and Maintenance Division."

One month later, in an addendum, the city strangely indicated that all bidders would be required to provide plans similar to a design-build project while also writing that it was not a design-build project.

A design-build public project is a construction delivery method used in public works or government projects. In this method, a single entity, the de-



# Pilmore Equestrian to Operate the Lakewood Equestrian Center

On Dec. 10, 2024, the Lakewood City Council approved a lease with Lakewood resident Cindy Flavin and her company Pilmore Equestrian LLC to operate the Lakewood Equestrian Center starting Jan. 1, 2025.

As part of her lease, Flavin has committed to invest at least \$1.2 million in immediate LEC improvements, such as new horse stalls, repairs to barn stalls and arena upgrades. The city will also invest \$150,000 in immediate improvements, focused on manure containment, trash enclosures and stormwater runoff prevention.

Over 90 horses are boarded at the LEC, with some of the owners providing lessons to the public. There is also a petting zoo, pony ride area and equine therapy operation on site.

Over 50 boarders and members of the LEC community came to the council meeting expressing support for Flavin's proposal, with several speaking in appreciation of the lease between the city and Flavin and their optimism for the future of the stables.

Earlier this year, the LEC had been at risk of closure because after several searches over a five-year period, the city had been unable to find an operator willing to invest in the facility and follow the many federal, state and local regulations concerning stormwater runoff, labor and other factors in operating a horse stable on public land.

"For all of these same reasons, many publically-owned equestrian centers in our region are closing or finding it very difficult to find an operator," said City Manager Thaddeus McCormack.

In June, the City Council held a spe-

cial public meeting detailing the increasing costs in city money and staff time diverted from other projects for the city itself to operate the LEC in the absence of a private operator.

At the June meeting, the council directed city staff to undertake a final effort to seek private operators for the stables. A nationwide search was carried out, with the participation of members of the LEC community. Five proposals were submitted, with the city selecting Pilmore Equestrian LLC, owned by Cindy Flavin, as the proposal with the best combination of financial capability, entrepreneurial skill and vision for the LEC

"Flavin's energy, enthusiasm and willingness to invest in and operate the LEC gives the facility a renewed life," said City Manager Thaddeus McCormack. "It was clear the city could not continue operating it ourselves. Temporarily operating the stable for the past year has required key members of our city staff to focus away from other city duties as they gave their best efforts to keeping the LEC on a steady footing while we searched for a new operator."

"We are very pleased that we have reached an agreement with Cindy," said McCormack, "and we will work with her to have a smooth transition from our operation to hers for the benefit of the people and animals who use the facility."

The 19-acre LEC, located on Carson Street just west of the 605 Freeway, is partly on city-owned land with a parcel running down the middle of the property owned by the Southern California Edison Co. and used by the LEC under a five-year license agreement renewable at the discretion of SCE.

can be found on the product's website.

The recalled products are packaged 2-pound plastic bags with "Best if used by" dates of 05/21/26 B10 and 06/23/2026 B1. Pet owners are urged to immediately dispose of the product.

Residents who fed their pets the recalled raw pet food products or other raw meat or dairy products and notice their pet is experiencing symptoms should immediately contact their veterinarian.

Public Health recently confirmed H5 bird flu in four house cats that consumed recalled raw milk and became sick and died, which is part of an ongoing investigation. Cats infected with H5 bird flu can develop severe illness that may including neurologic signs, respiratory signs or liver disease that can rapidly progress to

death. Public Health is also investigating additional possible cases of H5 bird flu in three house cats from a different household. One cat has tested positive for Influenza A, a rare result in cats that indicates possible H5 bird flu. Two other cats, which have died after worsening respiratory illness, are presumed to have also been positive for Influenza A. Public Health is awaiting confirmatory testing. These cats were not known to be exposed to raw milk, however public health is investigating other possible sources of infection, including raw meat.

Residents should avoid consumption of all raw milk and raw meat products and not feed these to their pets. Raw dairy, meat and poultry products, can harbor harmful bacteria and viruses, including H5 bird flu, which can pose serious risks to your health and the health of your pets. While consuming raw milk and meat products is never advised from a public health standpoint, the risk is especially concerning at this time, given the ongoing spread of bird flu virus among dairy cattle and following recent multiple detections of the virus in raw milk products.

#### **About H5 Bird Flu**

H5 bird flu refers to various strains of influenza A viruses that typically infect birds. While these viruses mainly affect wild birds, sometimes they also infect other animals, including wild and domestic animals (including seals, foxes, cats, and cows). H5N1 is one type of avian influenza that has been spreading among birds and mammals, leading to a nationwide outbreak. This is the first time these bird flu viruses have been found to be spreading in cows. The overall risk of H5 bird flu to the public remains low. There is currently no evidence of person to person spread of this virus.

Public Health has been working with the California Department of Food and Agriculture (CDFA) and the local LA County agricultural community to ensure key risk groups, including farm workers, workers at dairy, egg, and meat processing facilities and backyard flock owners receive information and resources to help identify and protect against this infection; this includes access to gloves, face masks and eye protection along with access to testing and flu vaccines.

Public Health yesterday confirmed the first case of H5 bird flu in a human in Los Angeles County who was exposed to livestock infected with H5 Bird flu at a worksite.

Symptoms of H5 bird flu virus infection in humans may include:

Eye redness or discharge

- · Cough
- · Sore throat
- · runny or stuffy nose
- · Diarrhea
- · Vomiting · muscle or body aches
- · Headaches
- · Fatigue
- trouble breathing

Symptoms in cats infected with H5 bird flu may vary and include:

- · Loss of appetite
- · Tiredness

· Respiratory and/or neurological

# Dancing Into 2025! **Martha Graham Dance Company, Alonzo King Lines Ballet and Twyla Tharp at** the Segerstrom Center 2025

Inspiring dance performances by the Martha Graham Dance Company, Alonzo King Lines Ballet and Twyla Tharp at Segerstrom Center highlight the beginning of 2025.

On January 18, 2005, the legendary Martha Graham Dance Company celebrating their 100th Anniversary with some of the original dance choreographies of the iconic Martha Graham. 'Graham 100" revives her classic "Appalachian Spring" created in1944 and "Immediate Tragedy" created in 1937 in response to the Spanish Civil War in a presentation and that also includes two new innovative choreographies 'CAVE' and 'We The People' created in the Martha Graham modern dance style.

"We The People", a choreography that is both a protest and a lament, is mobilized by a new musical score based on historic American folk music sound.

The 'power of the people' is the strong thematic concept that propels dancers with the overwhelming momentum that mobilizes their energetic movement. Belief in humanitarian values with hope that 'we the people' may live up to the ideals that will make the world a better place illuminates the stage.

The kinetic choreography of 'CAVE' reimagines the visceral energy of the techno dance scene onto the proscenium stage. Choreographer Hofesh Shechter, inspired by an idea by dance star Daniel Simkin, aligns

his innovative new movement with Martha Graham technique to create a contemporary modern dance masterpiece.

The composition from 1910, originally a piano duet with movements inspired by fairy tale themes, was orchestrated by Ravel in 1911.

On February 15-16, Twyla Tharp, 60th Anniversary with Third Coast Percussion, performs at Segerstrom Center featuring her diverse dance interpretations of the classic Beethoven's "Diabelli Variations" along with the ultra-modern Philip Glass composition "Aguas da Amazonia".

Twyla Tharp's ballet, jazz and street dance compositions meld into a dance art form set to the rhythm of stunning percussion, to generate a mesmerizing merger of movement and sound.

# **BOYS BASKETBALL Gahr Never Trails In Rare Rout Of Cerritos, Win Fourth Straight Over City Rivals**

Just about every season, there's a different component to the boys basketball city rivalry between Cerritos High and Gahr High. The last two games have ended in overtime wins by Gahr, seeking its fourth straight win over the Dons, which would mark the program's second longest winning streak since 1999.

The Gladiators didn't have to worry about their streak being snapped as senior Ethan Carey drained a three-pointer 52 seconds into the game and the hosts never trailed in a 63-39 victory. By the midway point of the third quarter, Gahr had a 33-point lead and was on the verge of the biggest win by either team in the history of the rivalry in the past 26 seasons, including tournament games. But Gahr's 39-point win in a Dec. 6, 2014 tournament game stands as the most lopsided win. The Gladiators also defeated Cerritos by 36 points in their normal meeting on Dec. 7, 2012.

"I talked to the guys before the game and said, 'hey, we've owned the city three years in a row; let's keep it

rolling'," said Gahr head coach Marcus Girley. "I think today there was a difference between some of the games in the past...the energy defensively, our length and our size kind of complicated their game plan. Our kids bought in early, and I think that kind of took a little air out of their sails and we kind of coasted."

"They just came to play; they played really well," said Cerritos head coach Jonathan Watanabe. "They shot the ball really well today and we should have done a better job on the defensive end of getting back and boxing out. But it is what it is."

Cerritos did not score until nearly two minutes into the game when senior Benson Cho's basket made it 5-2. The score would be 12-8 following a three-pointer from senior Nathan Ju before Gahr (6-5) began to pull away. A steal from junior Austin Woon, who dished the ball to senior Uchenna Okoli began a 9-0 run that covered the final 3:31 of the opening quarter. Then with the score 25-13 in the second quarter, the Gladiators outscored the Dons 10-0 over a span of 2:16 to put the game away.

Cerritos (4-8) was true on seven field goals in the first half, three coming on perimeter shots and another coming on a three-point play. It would not hit consecutive baskets until late in the third quarter, but even with a 44-18 halftime lead, Girley wasn't about to let his team celebrate just yet.

"The message has been this season is

a journey, and I've sent them a few videos," said Girley of his halftime speech to his team. "On your journey, you're going to fail; you're going to succeed, you're going to fall and you're going to get back up. Even when you reach the top, it starts back all over again. By halftime, hey, we're not up the mountain yet, brother. There's a long season to go, so let's come out [in the second half], still be hungry and understand Cerritos is going to come out in the first five minutes and give us everything they've got."

Meanwhile, it was a different message for Watanabe, who told his team to play harder, get back on defense and box out. The Dons had seven rebounds in the first half, partly because Gahr was 17 of 31 from the field.

"We talked about taking away the easy shots and we gave up all easy shots in the first half," said Watanabe. "It's hard when you're outsized by that much and you're giving them easy ones. It's difficult to win the game like that."

The beginning of the second half was more of the same with Cerritos scoring one basket in the first four and a half minutes while a three-pointer from freshman Bryce Titus with 4:17 left in the stanza made it 53-20. Cerritos responded by going on an 8-1 run the rest of the quarter as senior Demetrius Washington hit a trifecta, followed by a free throw and Cho scored on an offensive putback as the black and gold scored in succession for the first time.

"That's what you do; you just keep competing," said Watanabe. "You're trying to get better. In the preseason, it doesn't matter what your record is. We had the team two years ago go 1-10 and that same group of guys ended up winning a CIF championship [last year]. It takes time, so we have a brand new group of guys, and it takes time for them to learn to adjust to these games. Gahr came out and played well."

Gahr would score the first six points of the fourth quarter before the Dons concluded the final 3:28 of the game on an 11-3 run, highlighted by a four-point play from junior Aaron Shin. Cho led the team with 11 points and six rebounds while senior Jaylen Barsana added half a dozen points. Nine players scored a basket as Cerritos had its starting lineup of Barsana, Cho, Ju, Washington and senior Jaden Ribac together for the first time since Dec. 6. Watanabe has used that starting lineup six times in the first 11 games.

"There are no excuses," said Watanabe. "It doesn't matter how long you've been out. It might affect you offensively, but it shouldn't affect you defensively. We just got outplayed tonight."

For Gahr, sophomore Joshua Pearson led the way with 18 points, freshman Xavier Brown had a pair of three-pointers each in both quarters of the first half to finish with 12 points and Okoli added 11 points. It's the fourth game this season at least three players scored in double figures.

"Xavier is a scorer," said Girley. "He had been struggling the past few games and I [said] to both my freshmen, 'you have to let it come to you'. You can't seek out points; the basketball gods won't bless you. In this game, I thought he just played out the actions and took what the defense gave him in the first

"We're still developing leadership," he later said. "Sometimes on the court when [there are a] few bad possessions, sometimes we don't have that guy to get everybody together and rally the troops. Anytime we're talking and we're running our actions, we're a tough team to beat."

Since 1999, Gahr now owns a 20-13 series advantage which includes a 5-2 lead in tournament games. The two had co-hosted a tournament at the beginning of December and faced either in the championship game of that event six times. Gahr now has defeated the Dons eight times in 13 meetings at Gahr since Dec. 8, 2000.

Cerritos will head down to Rancho Penasquitos to participate in the Mt. Carmel Tournament, a staple with the Cerritos program every season, and will open bracket play against Eastlake High on Thursday afternoon.

"We're looking forward to it," said Watanabe. "We have seven seniors, three juniors, six sophomores, and so part of the thing is we need to travel so these guys become one family. They're very tightknit within the group, but as a whole...we need those five days in San Diego to kind of hang out and really become a family."

Gahr will stay in the Southland, but will be in The Classic at Damien, which has been around since 1981. The Gladiators are situated in the Silver Division and will open that bracket against Valencia High on Thursday afternoon at San Dimas High.

"There are no easy games," said Girley. "But I love the competition, and our kids have responded to big games and the big scenes. We'll be ready."

# Whitney's Defense Wreaks Havoc on Competition as Wildcats Head to Pacific Northwest

SAN PEDRO-Through the first 14 games of the season, the Whitney High girls basketball team has seen its share of good competition, bad competition and a little of both in between. But unlike previous seasons, head coach Myron Jacobs has had a slightly different approach to the season despite some opponents not as desirable as he would have liked based on the 11-player team he has.

No matter what the reason has been, or is, the Wildcats swept through the 3rd annual San Pedro Lady Pirate Shootout like it was nothing, breezing past Carson High 70-40 last Saturday night in the championship game. Whitney, not accustomed to playing teams from the CIF-Los Angeles City Section, faced the second of four teams from outside the Southern Section when they squared off against the Colts, and the game was over before the end of the opening quarter.

Going from the extremity of playing the caliber of a Lakewood High or a Rancho Cucamonga High in a span of five days in late November, then the Golden Valley Tournament in Merced from Dec. 5-7 to this tournament made Jacobs decide what his approach was going to be.

"Practice for Seattle, but most importantly, teaching the girls who are new to varsity," he said. "You only get so much time with them, and these are the perfect games to teach at the same time you go. Everybody wants to go and jump into hard tournaments to get battle tested. But in reality, we don't have that type of squad to go do that type of run. We would rather go somewhere where we can preserve players."

He's talking about a bigger challenge beginning Dec. 26 when Whitney will take part in the inaugural Holiday Classic Basketball Tournament at Kamiak High School in Mukilteo, just north of Seattle.

Sophomore Alyssa So had her opinion of facing the City Section teams, but made the most of this tournament

by scoring close to 70 points in the four games. She took the first four shots of the game for her team and five of the first seven, connecting on three perimeter shots.

"I think that L.A. City Section [schools] are much more physical than what we're used to," said So. "That was something that we knew coming into this. That was something we had to pay

attention to."

Whitney forced Carson to turn the ball over 11 times in the quarter with senior Haylie Wang picking up four of her game-high 12 steals in the first eight minutes. One of those led to her last basket of the stanza and made the score 17-5 with 1:50 remaining. The Wildcats let up a bit in the second quarter, scoring only nine points but they were still in

control with a 31-14 halftime lead.

Whitney grabbed 13 rebounds and forced another 11 turnovers in the second quarter as the Colts did not score consecutive points in the first half, and in fact, accomplished that feat three times in the game. One of the favorites to win the 605 League this season amped it up in the third quarter, scoring 19 points and for the third time, forcing 11 more turnovers. Wang was dominant again, scoring nine points in the stanza with four rebounds and a pair of steals.

"I'm a big believer in that you don't have to play a Division 1 or a Division 2 team to compete and get better," said Jacobs. "You just have to learn how to work on your system but use these types of tournaments to teach that and get them better."

Wang, who was named the tournament's most valuable player, scored 23 points, had a dozen rebounds, six steals and two assists while So added 20 points, four steals, three assists and a pair of rebounds. Also having solid games were senior Rachel Moyher (five rebounds, four steals), junior Tina Namaranian (nine points, three rebounds, two steals) and sophomore Keila Kurihara (10 points off the bench). Moyher, Namaranian and So were named to the all-tournament team.

"In the past, we've usually had about four girls who can play," said Jacobs. "This year, the motto is to get everybody ready, and every night [in this tournament], someone else stepped up. Somebody is always going to be off. You're not going to have one game where everybody is on it. Tonight, if you ask me, it was Keila who was on. Before that it was Haylie who was on [and] the day before that, it was probably Alyssa who was on.

"The components to this team winning is building more chemistry together and more playing time for the younger kids," he continued. "But most importantly, doing the things that we need to do in a system that we need to run to flourish."

"I think we did really well, especially because we were missing [sophomore] Cheyanne [Cheung]," said So. "She's a big part of our defense and she really does all our dirty work with the rebounding and defending. It was really hard not having her, but I think we did a good job of filling the gap she left and won for her. No one thought we were going to win, but we didn't let that deter us from trying our best and being really physical and not play like the underdogs that everyone thought we were."

Cheung, who was penciled into the starting lineup at the beginning of the season, missed the last three games of the tournament and will not accompany the team to the Pacific Northwest.

The Wildcats blew out El Segundo High 70-32 last Wednesday as Wang erupted for 29 points and had seven rebounds while So scored 21 points. Coming off the bench was Namaranian and she responded with a career-high 13 points along with three rebounds and three steals. The Wildcats led 26-10 after the first quarter.

The next night, the 'Cats feasted on Banning High in a 60-24 conquest with Wang pouring in a season-high 34 points and So adding 13 points. The best game of the tournament for Whitney came

sign-build team, is responsible for both the design and construction of the Proj-

In addition, the city did not provide an estimated cost for the Project.

At the November 13 City Council meeting, City Manager Raul Alvarez issued a report to the Mayor and Council recommending that KYA Services, LLC be awarded the contract for the Project. Alvarez's report indicated that the city received four "responsible" bids.

One was from Bridgerock Construction, Inc., at a cost of \$963,585; a second was from Asad Holdings, LLC, at a cost of \$1,190,000; a third was from KYA Services, LLC, at a cost of \$1,499,182; and a fourth was from Global Builders, Inc., at a cost of \$1,998,888.

Despite Bridgerock Construction's lowest responsible bid, nearly \$536,000

less than KYA Services, LLC, Alvarez recommended KYA Services, LLC, and the City Council unanimously approved Alvarez's recommendation.

WRR wrote, "The city has violated the Public Contract Code by failing to procure this Project via formal competitive bidding. We further apprise the city that its conclusions in the August 27, 2024 Addendum are incorrect and that the city must comply with the design-build requirements outlined in the Public Contract Code where it procures both the design and construction of a project from a single entity, accordingly, the city must rescind its contract with KYA Services for the Project, reject all bids, and procure the Project via formal competitive bidding or the traditional design-build model."

Under the Code, any public contract over \$200,000 must be disseminated under a formal competitive bidding procedure and contain several requirements, such as being published in a newspaper of general circulation at least 14 calendar days before the date of bid opening.

The Code also requires that the City Council must award any contracts to the lowest responsible bidder. In addition, the city may only award a contract for public works without plans where repair or replacement of city facilities is necessary due to emergency and pursuant to a four-fifths vote of the City Council.

Further, the city failed to prequalify bidders as required by the Code. No section of the RFP required the contractor to use a skilled and trained workforce for the Project; a great majority of public agency contracts are urged to use a Project Labor Agreement (PLA), which guarantees the contractor will hire locally and pay prevailing wages.

of this Project thus violates the formal bidding requirements of the Code and the Montebello Municipal Code. Consequently, any contract the city executes for the Project with KYA Services, LLC will be void and unenforceable. Thus, the city must abandon its void procurement of the Project, rescind any contract it has entered into with KYA Services, LLC, and procure the Project via the formal competitive bidding process required by the Code and the Montebello Municipal Code."

Now Los Cerritos Community News has obtained a letter from Montebello City Manager Raul Alvarez to Attorney R Maxwell Sinclair of WRR stating they will rescind the contract, calling into question why the contract was awarded in the first place. The letter stated, "be advised that City staff will be recommending that the Montebello City Council rescind the award made to KYA services WRR stated, "The City's procurement for the project, reject all bids for the project and reevaluate the project including the possibility of re-advertising the project as required under applicable law."
